## What is Fair Player Club?

In sport games, all players should comply with rules and principles in a 'Fair Play' spirit for fair and just competition. Likewise, in business, all market players should comply with the rule of law in a 'Fair Play' spirit for fair and clean business by promoting anti-corruption, compliance, and business ethics.

Fair Player Club aims to create fair and clean market conditions in Republic of Korea as a public-private platform for anti-corruption by mobilizing the commitments of all market players.

## What is Collective Action?

In collective action, companies work together with each other and with governments and civil society organizations "to create a fair and equal market and to minimize the risks of corruption."

Fair Player Club provides business participants and stakeholders knowledge, skills, strategies, and resources to promote ethical practices and transparency in business operations within their industry, region, and country.

<b>Capacity Building</b>	To increase awareness and competence of companies for clean and fair business practices with codes of conduct, guidelines and cases.
<b>Consensus Building</b>	To establish an alliance among market players from various industries, regions, and countries for interaction and learning.
